If you do not bring a signed waiver with you, one will be provided to you for an additional \$10 donation. Without your signed waiver, you will not be given a wristband or permitted to raft up and admitted to the party. This is for your protection. Thank you for understanding. \bigcirc

Minimum Party Donations: (Please Feel Free To Donate More)

- 1. First Time Attendee Wristband (if you're a couple & this is your first regatta ever with us and you've registered to attend by writing a thoughtful posting): Then your minimum donation is \$0. (Please feel free to donate more than zero if you like ☺)

- 2. I am fully aware of the risks involved and hazards connected with the activity, including but not limited to damages resulting from injuries from propellers, engines and motors, electrical generators, slip, trip and fall from ropes, lines, wet, moving and un-even surfaces, drowning, boat rafting, docking, launching and crashes, and I hereby elect to voluntarily participate in said activity with full knowledge that said activity may be hazardous to me and my property. I agree to abide by all laws and will not engage in any unlawful activities or bring or possess any unlawful drugs of any kind. I am not offended by nudity or sexual activity or acts or photos taken at the event. I voluntarily assume full responsibility for any risk of loss, property damage or personal injury, including death, that I cause, or that may be sustained by me. - 6. In signing this release, I acknowledge and represent that I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this release for full, adequate and complete consideration fully intending to be bound by same.

A separate release must be filled out and signed for EACH person participating in this event. You MUST print in VERY clear printed handwriting using only CAPITAL LETTERS. If you cannot write clearly or fill in

all the spaces, then your donation minimums are doubled. Every person must complete this form to get an attendance wristband.
